Our charges

Take off charge

Calculated on the basis of the aircrafts Maximum Take Off Weight (MTOW) as follows:

MTOW 4-5 tonnes, SEK = 325

MTOW 6 ton and above, SEK = 65 for each started ton

Minimum charge is SEK 250

Parking charge

Valid for all aircrafts parked on stands at Kalmar Öland Airport

1-4h free of charge

Above 4h parking cost SEK15/ton based on MTOW up to 24h

Minimum charge is SEK 150/24h

Local landingcard

The local landing card includes parking outside when available.

1 year fee

MTOW

0-450 kg 1.500 SEK excl VAT 25% (when applicable)

451-1000 kg 2.250 SEK excl VAT 25% (when applicable)

1001-2500 kg 3.125 SEK excl VAT 25% (when applicable)

1 month fee

MTOW

0-2500 kg 625 SEK excl VAT 25% (when applicable)

Passenger charge

Passenger charges are payable for all passengers to national and international destinations except taxi flights and private flights.

Domestic charge is SEK 68/ departing passenger

International charge is SEK 80/ departing passenger

Extended and extra opening costs

The charge is to keep ATS and rescue service open outside our normal opening hours presented in AIP

There is no charge when within 15 min from normal closing.

If more than 15 min the charge is per hour, minimum 1 hour.

Price per started hour for flights up to MTOW 18.000 kg is SEK 4.500

Price per started hour for flights with MTOW 18.001 kg -27.000 kg is SEK 5.600

Price per started hours for flights with MTOW 27.001 kg and more is SEK 6.700

If passenger service is needed there will be a charge of SEK 1.100 per started hour.

If extra opening is not in direct connection to normal opening hours according to AIP there is a minimum charge of 3h of above mentioned prices.

Incentive program Kalmar Öland Airport

For the regional development, Kalmar Öland Airport has created an Incentive program for new destinations from and to Kalmar Öland Airport

An airline or travelling agent qualifies for the incentive programs by fulfilling the following terms:

Regular Service (bookable both ways) 1)

- Minimum 2 departures and 2 arrivals a week.
- Must be a new destination that hasn't been operated the last twelve months from Kalmar Öland Airport.
- Arrivals and departures must be coordinated to the existing traffic to prevent high workload at the same time, thus creating increased costs for Kalmar Öland Airport. PEAK operations could disqualify new destinations from the incentive program.
- Route must be a non-stop flight to the destination.

Charters (only bookable from Sweden) 2)

- minimum 1 departure and 1 arrival a week.
- Minimum 6 weeks in a row or a 6 week expansion on an already existing operation of flights.
- must be a new destination that hasn't been operated the last twelve months from Kalmar Öland Airport.
- Arrivals and departures must be coordinated to the existing traffic to prevent high workload at the same time, thus creating increased costs for Kalmar Öland Airport. PEAK operations could disqualify new destinations from the incentive program.

New destination discounts 1) as above could be transformed to a fixed charge per pax for aircrafts over 100 seats. If the total new destination discount calculated as above, exceeds EURO 195 000, the discount will cease to exist and the charges will be calculated according to normal pricelist.

Payment of the charges and payment obligations

The aircraft owner, user and/or person acting as the representative of the owner of the aircraft are jointly and severally liable for the payment of the charges in this price list.

All rates are in SEK and are exclusive of any taxes or levies payable thereon. The total amount shall be rounded off to the next full SEK. Value added tax shall be paid according to the applicable law.

All charges prescribed according to this price list are due for immediate payment to Kalmar Öland Airport AB. Unless otherwise agreed in writing, the owner, pilot or representative of the

aircraft shall report to the Airport Office immediately before take-off or immediately after landing at the airport.

Invoicing is the standard form of payment at KLR. Agreement can be made concerning periodic invoicing, provided the owner or user of an aircraft operates on a regular basis or has higher volumes of traffic. Payment terms may not exceed 30 days.

Upon request, the airline is obliged to make all necessary information available to KLR for credit rating purposes. All information received will be treated confidentially.

If KLR considers the outcome of such credit rating to be unsatisfactory, the airport may request a first class on demand bank guarantee for a suitable amount from the airline in order to grant the airline periodic settlement of account.

In the event of failure to the charges due, the following provisions shall furthermore apply:

- Late payment will result in interest of overdue payments of 15.5%
- In the event of failure to pay, KLR may inform the airline that it will not be allowed to operate from KLR until all charges plus interest and service fees have been paid in full
- In the event of failure to pay, KLR is entitled by law to take legal action against the aircraft including but not limited to attachment of the aircraft itself, its fuel and engines irrespective of who may be from time to time the owner of such assets and KLR will, without incurring any liability from the owner of the aircraft, the holder and user thereof and any person action as the representative of the owner, the holder or user thereof be entitled to prevent the aircraft from departing from KLR until all charges have been paid in full
- Immediately after failure to pay, KLR may demand a Banker's guarantee for the amount due and for expected charges for the following three months
- After failure to pay KLR may change its agreed payment terms concerning periodic invoicing and revert to immediate payments for future take offs from the airport

Changes to the pricelist
